BCCA Report Unit Structure:

- All BCCA credit investigations for New or Updated Reports begin the first business day after receipt of request. Requests received before 8:30AM Central will be added to that day's work.
- Current Completed Reports (reports for which no additional work needs to be done) are charged as one [1] Report Unit.
- New or Updated Reports are charged as two [2] Report Units – members receive preliminary information on Reports within 48 hours of the date on which BCCA began the investigation.
- Rush Requests (requests for which the member needs preliminary information within 24 hours) are charged as four [4] Report Units.
- Within five business days members are sent a BCCA Credit Report which includes all reference responses to that point.
- A final report is sent within two weeks of BCCA's initiation of the credit investigation.
- Credit report units expire at the end of the membership year.

Additional Credit Report Units may be purchased during the membership year. Unused *Additional Credit Report Units* carryover to end of the membership year following the year in which they are purchased *providing the member renews for the following membership year. Additional Credit Report Units* are non-refundable.
